AUC inquiry into the ongoing economic, orderly and efficient development of electricity generation in Alberta Proceeding 28501

Letter identifying parties for questioning and week two oral submission/questioning scheduling

1. The Alberta Utilities Commission is conducting an inquiry into the ongoing economic, orderly and efficient development of electricity generation in Alberta.

2. During the week of December 11, 2023, the Commission will hear from municipalities, First Nations, Métis communities, corporations or industry associations, and other groups who registered to make a virtual oral submission on the inquiry topics for Module A. The schedule for oral submissions is attached to this letter, as Schedule A. The allotted speaking time for each party is based on the scope of written submissions and the interests represented. Parties should be prepared to respond to any questions the Commission may have following their oral submission.

3. December 14 and 15 were set aside for Commission questioning of experts who authored reports. The Commission has identified the following experts to question. There will not be an opportunity for direct examination of the experts.
